Policy type

Eligible sources

RPS

- Biofuel
- Biogas
- Biomass
- Clean Hydrogen
- Distributed Generation
- Geothermal
- Hydropower less than 30 MW
- Solar
- Waste-to-Energy
- Wave/Tidal less than 100 MW
- Wind

CES

- Fossil Fuels with CCS
- Fusion
- Hydropower greater than 30 MW
- Nuclear Energy greater than 30 MW

Targets

- Interim:** RPS – 40% by 2030 and an additional 1% annually; CES – annual requirements, starting at 16% in 2018, and increasing every year to 60% in 2030 (90% including the CES-E (existing hydro and nuclear energy), which is determined by formula)
- Final:** CES – 100% by 2050 and each year after; including the CES-E (existing hydro and nuclear energy), which is determined by formula

Economy-wide goal: Net-zero by 2050; emissions must be 85% below 1990 level, with sector-specific limits

Point of regulation: Retail sales

Regulated entities: Investor-owned utilities, retail suppliers

Percent of retail sales covered by RPS: 89%

Implementing agencies: Massachusetts Department of Environmental Protection (MassDEP), Massachusetts Department of Energy Resources (DOER), and Massachusetts Executive Office of Energy and Environmental Affairs (EEA)

Enforcement mechanisms: Penalties for noncompliance, enforced as an administrative order or civil administrative penalties

Compliance flexibility and cost containment: CES – Alternative Compliance Payment (ACP) with a rate of \$35 per MWh from 2022–2050; CES-E – ACP rate of \$10 per MWh from 2022–2050

Carve-outs and incentives: CES – Minimum of existing hydropower and nuclear, based on a formula; RPS – mandated target of 1600 MW by 2020 of in-state solar photovoltaics, mandated target of 5.6 GW by 2027 of offshore wind

Compliance tracking: [NEPOOL GIS](#); Required annual compliance filings of progress and emissions

Notable features: Municipal electric departments and municipal light boards are exempt but can opt in

Recent updates: SB 2967 added fusion as an eligible source for CES
